#### **Unfinished business**

Options for resolving the water drainage issue on Lynwood Lane were discussed with Tim Nestle and Van Johnson, representatives of the Mecosta County Road Commission. The road commission gave permission to have the Chippewa/Martiny Fire Department flush the drainage pipe that goes into the lake to be sure it is not blocked.

The Road Commission will also request permission from Mr. Rutter and Mr. McKay, the two property owners nearest the current drain, to access their property for the purpose of calculating elevations. The goal will be to determine if it would be feasible to drain water across their property to the lake by direct boring a drainage pipe.

Security cameras at the town hall were installed by Benny Blanzy and grant documents have been submitted to the PAR plan for reimbursement.

The new 16ft dock section was added to the boat launch Horsehead Lake.

Gravel at the Pretty Lake driveway was added on September 7th. A thank you note will be sent to Mr. Tipton and Mr. Pung for their work on leveling the gravel and coordinating the project.

### **New business**

Resolution Cindy/Lois to authorize the Township of Martiny operating millage rate of 1.2017 for the tax year 2022. Roll call vote 5 yes. 0 No. Resolution carried

Trash day went smoothly with just over 50 residents participating. This is approximately the same number as spring 2022 and fall of 2021.

While installing the security cameras Benny Blanzy noticed there appears to be a small leak in the roof near a vent pipe from the bathroom. Chris Krikke was contacted to evaluate the issue.
